Investment objective

The Fund aims to provide long-term capital growth and income by investing in a portfolio of inflation-linked bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR. The Fund aims to have a higher ESG score than its reference benchmark.



Investment strategy

The Fund is actively managed.

The Fund will normally invest at least 70% of its assets in bonds, the value of which is linked to inflation.

The Fund invests in bonds issued by companies, governments or government related entities of developed markets and emerging markets. Up to 15% of the Fund's assets may be invested in emerging markets.

The Fund includes the identification and analysis of a company's ESG credentials as an integral part of the investment decision making process. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time

The Fund may invest up to 10% of its assets in onshore Chinese bonds and up to 10% in other funds. The Fund will not invest in securities from issuers with a credit rating below investment grade at purchase.

The Fund's primary currency exposure is to US dollars.




