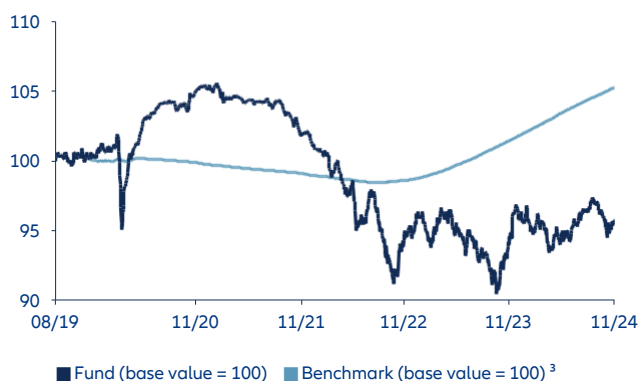

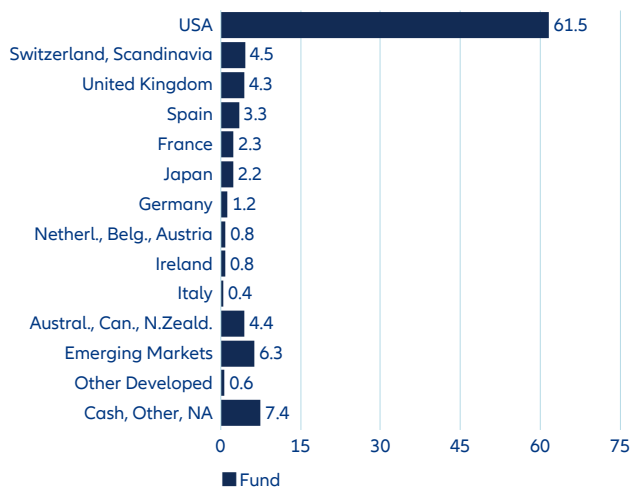

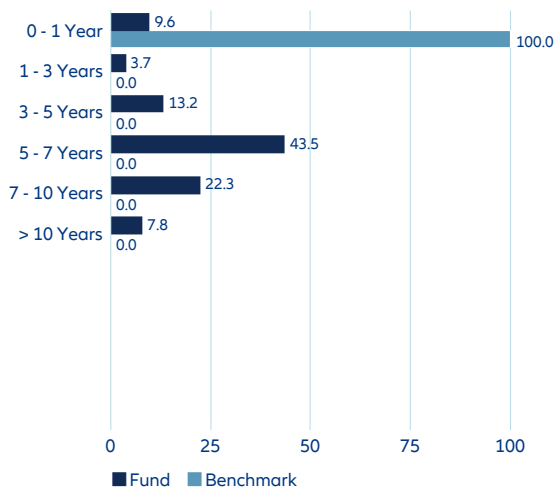

Country/Location Breakdown (%) (weighted by market value)



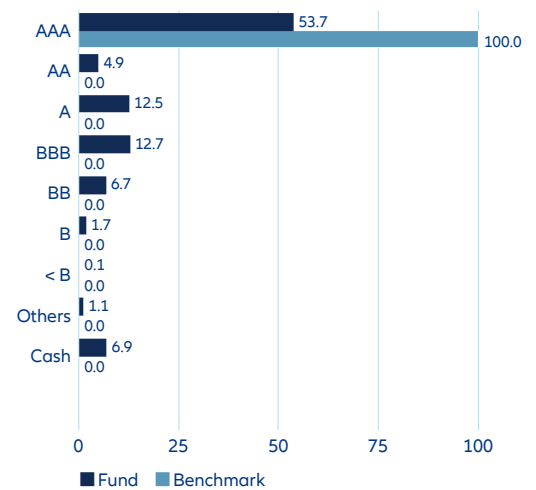
Duration Breakdown (%) (weighted by market value)
