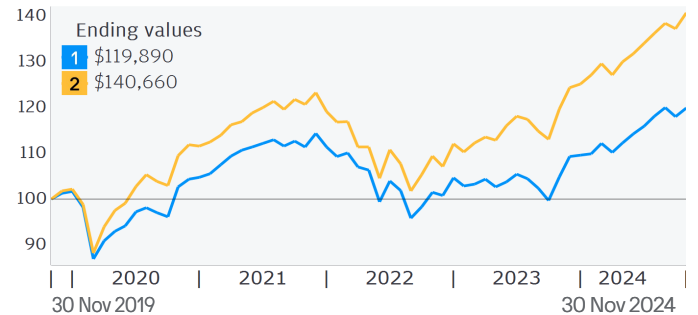

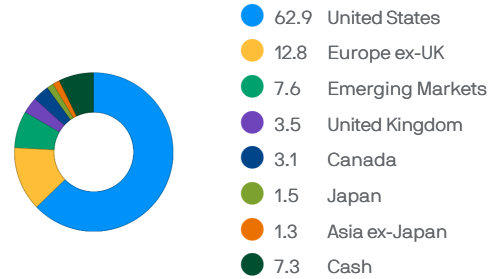

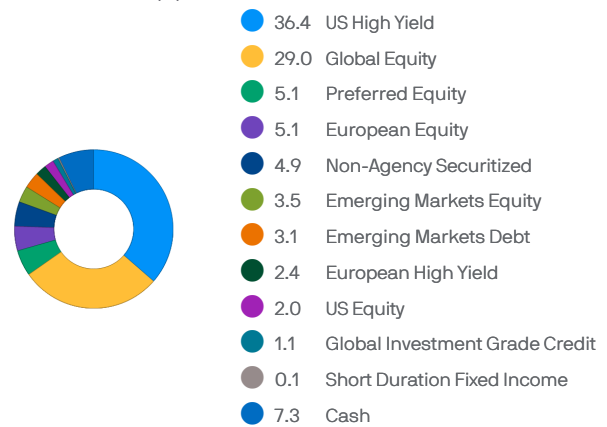

Definitions
